

## **PRIVACY STATEMENT Six Center Motoren**

This is the privacy statement of Six Center Motoren. In this statement we explain how we handle the personal data that we obtain in our contact with you. Six Center Motoren complies with the provisions of the General Data Protection Regulation (GDPR).

### **Introduction**

### **Personal data that we process:**

- First name and last name
- Sex
- Address and city
- Email address and phone number
- List of customer contact details via an app
- Bank account number
- Images of delivered products and delivery times
- Required legal data for required license plate registration
- Other personal data that you actively provide, for example by placing an order, in correspondence and by telephone.

## **For the following purposes:**

- Processing your application, order and payment
- Handling your payment
- To be able to call or e-mail you if this is necessary to be able to perform our services
- Informing you about changes to our services and products
- To deliver goods and services to you
- Product tracking
- Our marketing and online placements
- Sending a newsletter and/or advertising brochure
- Six Center also processes personal data if we are legally obliged to do so.

## **Who do we pass on your data to?**

We only pass on the necessary data to other parties if this is necessary for our services such as delivery, etc.

## **How long do we keep your data?**

We do not store your personal data for longer than is necessary for the purposes for which this data was collected.

## **What are your rights?**

As a customer you have a number of rights regarding your personal data. You can view, change, destroy and transfer these. ## **How is your personal data secured?**

## **What do we use cookies for?**

During a visit to the site, cookies may be placed on the hard drive of your computer and this solely to better tailor the site to the needs of the returning visitor. These mini files or cookies are not used to check the surfing behavior of the visitor on other websites.

## **Applying, what do we do with your application data?**

In connection with an application or application, you may provide us with information about yourself, such as a resume or curriculum vitae. We may use this information in Six Center for employment considerations. We will keep the information for future consideration unless you ask us not to. Your personal data will be saved if you actually start working for us.

## **Special and/or sensitive personal data that we process**

## **View, modify or delete data**

You have the right to view, correct or delete your personal data. This means that you can submit a request to us to send the personal data we have about you in a computer file to you or another organization mentioned by you.

To ensure that the request for access has been made by you, we ask you to send a copy of your proof of identity with the request. Make your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and Citizen Service Number (BSN) black in this copy. This is to protect your privacy. We will respond to your request as soon as possible, but within four weeks.
